DEERFIELD APPLICATION FOR GOLF MEMBERSHIP 2018

I hereby make application for golf membership in Deerfield Country Club, Inc., and if elected to this membership, do unconditionally agree to comply with and abide by all **RULES**, **POLICIES**, and **BYLAWS** of this Club as established or modified by its Board of Directors or Stockholders. I understand that this membership term is for a **FULL YEAR** commencing on the first day of January 2018 and extending through December 31, 2018. I further understand that I am responsible for full payment of dues for the **FULL YEAR** including tax.

Dues may be paid in two equal installments, the first due by January 1, 2018 and the second due by July 1, 2018. Paying dues in two installments does not imply that Deerfield has ½ year memberships. Two installments are for the convenience of membership payment only. Dues paid in full by February 28, 2018 will receive a discount. No discount will be given if payment is made in two installments or paid after February 28, 2018. Dues can be paid by **cash, check, credit card or debit card.** These are the only acceptable methods for paying membership dues. Deerfield will be Semi-private for the year of 2018. You can be a member or a Greens Fee Payer.

Payment for items like cart fees, green fees, lockers and other purchases at the club house can be paid by **cash**, **check**, **debit card or credit card**. You can have the amount charged to your account for <u>60 days and 60 days only!</u> A **10% compounded interest per month** will be charged to your account at the end of each month. Statements are mailed the first of each month and are payable by the **20**th. At the end of that month, if payment has not been received, you will not be able to charge to your account until paid in full. I agree to the conditions stated and will pay my account in **full in 60 days**.

I further agree to indemnify, release Deerfield Country Club, Inc., and its agents and employees, harmless from all claims, demands, actions, liabilities, damages, losses and injury to person and property, arising from or as a result from this membership in Deerfield Country Club, Inc., its agents and employees, members and or guests. You must have a Driver License to operate a Golf Cart and Deerfield Country Club does not allow and will not be liable for any injury, pain and suffering, death of a member or guest, trespasser, Deer Hunter or any person operating an ATV or any other type of recreation vehicle, personal vehicle or work vehicle on Deerfield Property.
